

## Post Arts Veto Advocacy Sample Letter

Please feel free to use this letter to advocate for the restoration of art funding in the 2025 Florida state budget.

We have inserted a link allowing you to find your state representatives so that you can send the letter directly to them.

Use these tips to ensure your letter will be read:

- 1. Personalize your letter for the most impact and persuasion. Explain how the issue affects you, your organization, or your community. Include specific examples, such as: We are now cutting an education position and are unable to offer arts education to children from Community Elementary.
- 2. Please maintain respect and civility in your communications. We all respond best when we are treated with courtesy and respect.
- 3. Personalize your relationship: Indicate if you have ever voted for them, met them, supported their election campaign, etc. The letter may be more effective if the politician feels closer to you.
- 4. 4. If you are emailing this letter, please cc their aides, as well. (Emails for all linked here).

As such, I'm a recommended grantee vested in continued appropriations for the Arts and Culture grant funding through the Department of State in the 2026 state budget.

Our nonprofit arts and cultural community relies on State funding to thrive and continue supporting the wellbeing, education, and civic engagement of our patrons. Our organization also supports that the pandemic devastated the arts community, leading to the loss of revenue, membership, and attendance at cultural institutions across the county. Three years later, attendance is returning, but has not stabilized at the pre-pandemic levels. The cuts to State arts funding represent a significant setback for our organization and we ask that you reinstate full funding to the Arts and Cultural line items.

Impact of the vetoes on your organization

The arts support our government as much as you support the arts. In Pinellas County, the arts and cultural sector generated \$294.7 million in economic activity during 2022, supported 4,528 jobs, provided \$185.3 million in personal income to residents, and generated **\$58.9 million in tax revenue to local, state, and federal governments.** 

I ask that you vote for future arts funding for Pinellas County's cultural institutions in the 2026 budget.

To fully fund Pinellas County's Culture Builds Florida Grant at the 2024 level, \$4,030,098 must be appropriated.

To fully fund Pinellas County's Cultural Facilities Grant at the 2024 level, \$14,095,214 must be appropriated.

To fully fund Pinellas County's Cultural Endowment at the 2024 level, \$960,000 must be appropriated.

I ask that you stand strong to represent our arts and cultural community in Pinellas County. Arts and culture is more than food for the soul. It also puts food on the table, attracts new businesses, brings in tourism revenue (1 in 4 visitors enjoys an arts experience during their visit), encourages residential growth, and contributes to the expansion of our County's economy.

While I am focused primarily on Pinellas County, I ask that you look at how the arts uplift the entire state's growth, and vow to continue funding the 864 statewide arts and cultural organizations whose recommended funding was vetoed.

I ask that you join our community in advocating for the upcoming 2026 Division of Arts and Culture funding request.
